**Mutton Bustin' weigh-in and entry processing for selected riders (you will be notified by telephone prior to the fair) will be held on Wednesday night August 14th between 5:00 p.m. – 7:00 p.m. for all riders. No late arrivals will be accepted. Weigh-in will be in the fair office. Participants must be weighed in with similar clothing that will be worn during the event (See rules below). NO MORE THAN 12 RIDERS PER NIGHT.**

**Mutton Bustin' Rules and Regulations:**

1. Only a parent or legal guardian may register a child in the Mutton Bustin' Event.
2. A completed application along with a signed release form must be returned for child to have an opportunity to compete in the event.
3. The number of participants is limited due to time constraints. In the event that more entries are received than the number of spots available a drawing may be held to select participants. Entry forms must be **received** by August 1, 2019. No late entries will be considered. The Pend Oreille County Fair, Rodeo, volunteers and stock providers are not responsible for late or misdirected entry forms.
4. Participants must wear long pants, boots or sturdy shoes (no open toed shoes, flip flops or sandals) and long sleeved shirts. Failure to wear the appropriate clothing will result in forfeit of participant's opportunity to ride. **Decision of volunteers in charge of Mutton Bustin' is final.**
5. Participants will be provided a bicycle or riding helmet and a neoprene (or similar) vest which **MUST** be worn during the ride.
6. Participants must be between the ages of 4 and 7 as of August 1, 2019 **and weigh no more than 60 pounds** on the scales used by the volunteers at the time of weigh-in.
7. Top performer of the night, as judged by selected judges, will be awarded a prize. In the event of a tie score a ride-off may be performed.
8. Event happens rain or shine.
9. **One (1) parent/legal guardian** may accompany the rider to the chutes. No others will be allowed in the arena or on the back of the chutes. No other children will be allowed in the area with the parent/legal guardian.
10. A \$5 participation fee must be paid in cash at the time of the official weigh-in.

**PEND OREILLE COUNTY  
WAIVER OF LIABILITY RELEASE AGREEMENT**

In consideration of being allowed to participate in any way in this activity/event and/or being permitted to enter or use the Fair facility, I/we hereby acknowledge and agree as follows:

I/we represent and warrant that I am /we are the PARENTS/PARENT/LEGAL GUARDIAN of the MINOR PARTICIPANT named above and I/we have the full power, authority, capacity and right, without limitation to enter, execute, deliver and preforms this WAIVER OF LIABILITY (“Agreement”). I acknowledge that:

- (a) I have carefully read the foregoing agreement in its entirety and understand it;
- (b) I acknowledge that the MINOR PARTICIPANT is physically able to participate in the Event;
- (c) I am /We are aware of the risks associated with the physical nature and character required to participate and engage in the Event, and
- (d) I/We hereby agree that I/we will abide by all rules and regulations of this Pend Oreille County Fair Mutton Bustin’ activity/event.
- (e) I/We hereby acknowledge and agree that the activity of **Mutton Busting** and/or livestock events are dangerous activities and that a participant is subject to a substantial and/or serious hazard which may result in property damage and/or personal injury or death.
- (f) I/We understand that an animal, irrespective of its training and usual past behavior and characteristics may act or react unpredictable at times, including but not limited to expected and unexpected behaviors or reactions, based upon instinct or fright which is a risk to be assumed by each participant in the Event and I/we assume these risks on behalf of the MINOR PARTICIPANT.
- (g) I/We also recognize that the Pend Oreille County Fair will not provide instruction or supervision to the MINOR PARTICIPANT.

In consideration of the Pend Oreille County Fair accepting this entry, I/we the undersigned for myself/, my heirs, executors, administrators, and assigns, to be legally bound, assume all risk of injury to my/our persons or property and/or my/our MINOR PARTICIPANT’S person or property and waive and release any and all rights and claims for damages I/we may have against

Pend Oreille County, its agencies, agents, officers, employees, and sponsors for any and all injuries and damages suffered to me or my property in, or arising out of, this event or during any transit to/from this event.

Further, I/we hereby agree to hold harmless, indemnify and defend Pend Oreille County, its agencies, agents, officers, employees, and sponsors from any claim of third parties arising out of my/our MINOR PARTICIPANT'S participation in this event or during transit to/from this event.
